Any member, session, presbytery, synod, or entity of the PC(USA) may endorse persons for the consideration of the GANC but only after careful evaluation of the individual's applicable skills and experience as well as the endorsee's ability to give the required time to the task.

A GANC member may make contact with middle governing bodies, sessions, or other persons, for additional information. Endorsement does NOT assure nomination.
